

Rebook Rush Competition Terms and Conditions

1. Organiser

The Rebook Rush competition (“Competition”) is organised by Collegiate UK, a trading name of Collegiate AC LTD

2. Eligibility

- The Competition is open exclusively to current residents of Collegiate UK properties.
- Participants must submit a game entry and complete an entry form with their name, email, and current property address to be eligible for prizes.
- Employees of the Organiser, their families, and anyone directly involved with the organisation or administration of the Competition are not eligible to participate.

3. How to Enter

- To enter, participants must play the Rebook Rushgame, achieve a score, and submit the entry form provided.
- Whilst participants can play the game an unlimited amount of times, Each participant is permitted only one entry. In the case of multiple entries ranking in the top 10, only the entry will be counted.
- Entry implies acceptance of these Terms and Conditions.

4. Competition Period

- The Competition opens on 28/10/2024 and will close on 30th November 2024 at 23:59 GMT.
- Entries submitted after the closing date will not be considered.

5. Prizes

Leaderboard Prize: The participant who finishes at the top of the leaderboard at the close of the Competition will win a £750 Inspire Travel gift card.

Top 10 Prize: All participants who rank in the top 10 on the leaderboard will be entered into a prize draw to win a £250 ASOS voucher.

- The Top 10 Prize draw will be conducted randomly from the top 10 leaderboard positions.

- If a winner does not respond within 7 days of notification, the Organiser reserves the right to select an alternate winner.

- The Inspire Travel gift card and ASOS voucher are subject to the respective terms and conditions of Inspire Travel and ASOS, which winners agree to be bound by upon receipt

and use of their prizes.

- Prizes are non-transferable, and no cash alternative will be provided.
